# 4. First Aid Measures

# **Eyes**

Flush thoroughly with water. If irritation occurs, get medical assistance.

Wash contact areas with soap and water. #### **Inhalation**

# **Extinguishing Media**

#### **Fire Fighting**

Evacuate area. Prevent runoff from fire control or dilution from entering streams, sewers, or drinking water supply. Firefighters should use standard protective equipment and in enclosed spaces, self-contained breathing apparatus (SCBA). Use water spray to cool fire exposed surfaces and to protect personnel.

#### **Unusual Fire Hazards**

#### **Notification Procedures**

#### Spill Management

Large Spills: Dike far ahead of liquid spill for later recovery and disposal. Prevent entry into waterways, sewers, basements or confined areas.

# <u>Handling</u>

Avoid breathing mists or vapors. Small metal particles from machining may cause abrasion of the skin and may predispose to dermatitis. Prevent small spills and leakage to avoid slip hazard.

Do not store in open or unlabeled containers.

#### 8. Exposure Controls / Personal Protection

Exposure limits/standards for materials that can be formed when handling this product: When mists/aerosols can occur, the following are recommended: 5mg/m3 – ACGIL TLV, 10mg/m3 – ACGIH STEL, 5mg/m3 – OSHA PEL. Note: Limits/standards shown for guidance only. Follow applicable regulations.
